## PHILANTHROPY IRELAND

### **Criteria for Membership**

The Board of Philanthropy Ireland determines the criteria for eligibility for membership. To be eligible to apply for membership of Philanthropy Ireland, the following criteria must be met:

- Applicants engage with or support Philanthropy Ireland mission, but do not meet the criteria for full membership.
- Grant-making or social financing is not the core focus of their overall activities.
- Applicants work in related, supportive, or otherwise similar fields to that of Philanthropy Ireland or of its Full Members
- Applicants commit to upholding the highest levels of accountability, including in relation to governance, financial management, and transparency.

### Associate members have access to a range of Philanthropy Ireland benefits as outlined above but do not:

- Have voting rights on issues such as Board Directors, constitutional changes etc.
- Have access to grant making network meetings, including open call, thematic or other meetings determined to be of specific interest to grant makers only.

### Membership application process:

- 1. Applicants wishing to apply for membership of Philanthropy Ireland shall:
- 2. Complete a short application form as provided by Philanthropy Ireland.
- 3. Membership suitability will be determined by Philanthropy Ireland.
- 4. Outcome of assessment of suitability will be conveyed to the applicant within two working weeks. If deemed suitable, we will proceed to step 4. If unsuccessful we will notify the applicant without any obligation to assign a reason therefor.
- 5. A membership brochure and Codes of Conduct will be forwarded to the applicant, along with an outline of our onboarding process.
